- The Grade 6 students help with the volunteering and rolling of the coins. Will look to Grade 6 classes for volunteers (Lisa to send)
- Perhaps discuss with the owners of a grocery store to see if freezies could still be ordered off season. (Candis L to check with stores re: ordering)

• Swimming Lessons:

- Have been exploring options to provide swimming lessons for the kids.

- Most schools do not do a school wide approach. Look at a grade approach. Perhaps Grade 3 and 4 – this is done at other schools. Not sure what the right approach would be for which grade.
- Also an option for a "fun swim" booking where other grades can come \$6.75 per student
- Will also need to look into the ability to do the bussing. (roughly 2 classes per bus)
- \circ 3 is the only grade without a split class to be into consideration.
